### **Charity Runner**

**Fundraising Commitment:** Members of the CAC Boston Marathon Team commit to meeting their fundraising goal (page 2) in exchange of receiving one of the allotted CAC bib numbers for the 2022 Boston Marathon. Charity Runners agree fundraising will be complete by June 1, 2022 either through their personal effort or direct payment.

**B.A.A.** Registration: Upon your invitation to officially join the 2022 CAC Boston Marathon Team as a Charity Runner, the CAC will provide you with the Boston Athletic Association Invitational Entry Application. You should not contact the B.A.A. directly to secure your number. The B.A.A. race application fee is \$205. (Other fees may apply.) The application fee is the responsibility of the runner and will be paid directly to the B.A.A on submission of your application; the application fee does not count towards your fundraising goal.

## **Registered Runner**

Fundraising Commitment: Registered Runners of the CAC Boston Marathon Team commit to raising meeting their fundraising goal (page 2) to ensure every child & family in need can access support at the CAC. Registered Runners agree fundraising will be complete by June 1, 2022.

B.A.A. Registration: Registered Runners secure their race bibs directly from the Boston Athletic Association.
